## **Membership Levels**

### **Stock Holder:**

- \$500 Stock Purchase; \$300 Initiation Fee; \$250.00 Dues
- Entitled to all privileges of the club, including the right to vote and hold office. This offers full access to golf, dining, and swimming facilities, as well as involvements in all social activities for the member, member's spouse and dependent children, as defined by the club.

### **Social/Stock:**

- \$500 Stock Purchase; \$75 Initiation Fee; \$100.00 Dues
- Entitled to all privileges (excluding golf) of the club, including the right to vote and hold office. This offers full access to dining, and swimming facilities, as well as involvement in all social activities for the member, member's spouse and dependent children, as defined by the club.

### **Associate:**

- \$300 Initiation Fee; \$250.00 Dues
- Entitled to all privileges of the club, but does not have a voting right and is unable to hold office. This offers full access to golf, dining, and swimming facilities, as well as involvement in all social activities for the member, member's spouse and dependent children, as defined by the club.

### **Social:**

- \$50.00 Initiation Fee; \$75.00 Dues
- Entitled to clubhouse privileges, and the swimming pool, for the member, member spouse and dependent children, as defined by the club. This membership does not have the right to vote or hold office.

### **Junior:**

- \$300 Initiation Fee; \$195.00 Dues
- Entitled to all privileges of the club to age 35, but does not have a voting and is unable to hold office. Member must upgrade to Stock or Associate at age 35.
- This offers full access to golf, dining, and swimming facilities, as well as involvement in all social activities for the member, member's spouse and dependent children, as defined by the club.

### **Junior/ Stock:**

\$500 Stock Purchase; \$300 Initiation Fee; \$195.00 Dues

- Member must upgrade to Stock or Associate at age 35.
- This offers full access to golf, dining, and swimming facilities, including the right to vote and hold office, as well as involvement in all social activities, for the member, member's spouse and dependent children, as defined by the club.

### **Non-Resident:**

- \$250.00 Initiation fee; \$200.00 Dues
- This membership is for members that maintain their primary residence outside Navarro Country. You are entitled to all privileges of the club, but do not have a voting right and is unable to hold office. This offers full access to golf, dining, and swimming facilities, as well as involvement in all social activities for the member, member's spouse and dependent children, as defined by the club. There is no food minimum for this category of membership.

### **Non-Resident/Stock:**

- \$500 Stock Purchase; \$250 Initiation Fee; \$200.00 Dues
- This membership is for member that maintain their primary residences outside Navarro County. This offers full access to golf, dining, and swimming facilities, including the right to vote and hold office, as well as involvement in all social activities for the member, member's spouse and dependent children, as defined by the Club. There is no food minimum for this category of membership.

### **Rewards:**

- \$199.95 Initiation Fee; \$159.00 Dues
- This Membership is entitled to all privileges of the club, but does not have a voting right and is unable to hold office. This offers full access to golf, dining, and swimming facilities, as well as involvement in all social activities for the member, member's spouse and dependent children, as defined by the club.
- Promotional dues are locked in for 1 year and a 10% dues increase on the anniversary date for 5 years which will be \$250.00 per month by the 5<sup>th</sup> anniversary date.
